An Act Creating an Ad-Hoc Committee During the GSG 2025-2026 Session for the Graduate Assistant Advisory Committee

Summary: This legislation creates and charges a Graduate Assistant Advisory Committee (GAAC), mirrored within GSG, with the support, planning, and execution of legislatively mandated responsibilities during the GSG 2025-2026 session.

FOR THE PURPOSE OF supporting, planning, and assisting in the execution of the Graduate Assistant Advisory Committee's legislative responsibilities, charges, and constitutional roles;

BY creating an ad-hoc GAAC standing pursuant to the GSG Constitution Section 4.3.D;

BY establishing the elected lead convener of GAAC and the constitutionally established representatives to GAAC within GSG as co-chairs of the 2025-2026 session of the committee;

BY charging GAAC with the execution of collaborative advocacy among graduate assistants (research, teaching, administrative, and all other), especially as it pertains to regular meetings of the committee with administrators, election support, and other duties within the bounds of GSG's constitutional mandate.

AND BY charging the Assembly with consideration of the inclusion of the Graduate Assistant Advisory Committee in Article 5 of the Bylaws by no later than the final session of the 45th General Assembly.
